## **Editorial**

Much to our delight the current federal funding period 2017 to 2020 allows us to install and maintain the clinical pediatric research hubs within our member institutions throughout Switzerland.

The financial amount granted to SwissPedNet enables each hub, SwissPedRegistry and SwissPedPha to employ 0.5 to 0.7 FTE for their research infrastructures urgently needed to perform clinical research studies on a national and international level. Service Level Agreements with all our members regulate the use of the federal funds. The SwissPedNet General Assembly released in November 2016 rules of Procedures within each hub and between individual hubs, which are adopted by all member institutions. In addition, milestones and deliverables guide us to follow up on our target to become a reliable and well-working research infrastructure for pediatrics in Switzerland but also in Europe and overseas and to materialize our vision:

All children in Switzerland have access to high-quality research in well-equipped research infrastructures, independent of their age, pathology, and living location.

Pediatricians and other health professionals caring for children in Switzerland conduct clinical research at international highly competitive level, exhibit impressive charisma, and are uniquely recognized with all its disciplines and sub-disciplines within their own country and abroad.

Our General Assembly 2017 set the stage for a successful network – we had fruitful discussions with the main stakeholders and key players in pediatric clinical care and research in Switzerland. Most notably, representatives of the Swiss society of Paediatrics, the Foederatio paedo medicorum helveticorum, the Swiss association of the health of adolescents, the Swiss society of child and youth psychiatry and psychotherapy, the Swiss society of pediatric anesthesia, the Swiss pediatric surgery society, the Swiss society of neonatology and the Swiss pediatric oncology group followed our invitation and are eager to collaborate together.

As of 2018, Klara Posfay Barbe will preside SwissPedNet. She already collaborated in the board as president elect since the beginning of 2017, and we are all very happy that she takes over. I wholeheartedly wish her all success and support from the entire pediatric community of Switzerland.

# **SwissPedNet Highlights 2017**

## Entering as beneficiary into the funding period 2017 to 2020

SwissPedNet has eventually succeeded receiving federal funding for its member institutions. The SERI financially supports SwissPedNet, the clinical pediatric research infrastructure, with CHF 3.1 Mio. This amount enables each hub, SwissPedRegistry and SwissPedPha to employ 0.5 to 0.7 FTE for their research infrastructure urgently needed to perform clinical multi-center studies.

## Collaboration with sgp/ssp

The Swiss Society of Pediatrics (sgp/ssp) officially mandated SwissPedNet to conduct pediatric clinical research in Switzerland. The Collège A supports this mandate via their clinical pediatric hubs.

SwissPedNet and sgp/ssp launched their scientific collaboration with a call for study projects in pediatric health services research In September 2017. The call is open until 28.2.2018 and the winner will be announced during the SwissPedNet Translational & Clinical Research Session on 24.5.2018 in Lausanne.

The topic of the proposed investigation must be relevant for outpatient care with a wide-ranging scope, must focus on patient-oriented research and may include healthy individuals as controls. No laboratory, early phase or proof of concept studies will be funded as well as no studies conducted for directly commercial purposes.

# **Activities and Projects in 2017**

#### SwissPedNet entered into contract with each member institution

SwissPedNet concluded Service Level Agreements with each member institution for the use of the federal funds. Milestones and deliverables for each hub are defined and will be harmonized between each other.

#### SwissPedNet Translational & Clinical Research Session

SwissPedNet organized the 5<sup>th</sup> edition of the SwissPedNet Translational & Clinical Research Session on June, 2017 during the SGP/SSP congress in St. Gallen. Ten young researchers received the opportunity to present their work during 10 minutes talk and adjacent explanations and dialogue with the audience, after submitting their studies and research projects to the judging panel. The research projects covered all disciplines of pediatrics; beside clinical and epidemiological questions also studies in basic research have been presented. Along with the content itself, the judging panel evaluated the performance and the following discussion of the young researchers.

#### **Ethic Standards for Pediatrics**

swissethics published the "Leitlinie zur Forschung mit gesunden Kindern und Jugendlichen" / "Guide concernant la recherche sur des enfants et des adolescents sains".

This document has been elaborated in collaboration with experts from SwissPedNet.

#### **SwissPedRegistry**

SwissPedRegistry started its activities for the entire Swiss pediatric research community in spring 2017.

The purpose of SwissPedRegistry is summarized as follows: SwissPedRegistry represents the interests of pediatrics in meetings relevant for registries and observational studies (national, international, federal), they develop methodologies and instruments for pediatric registries, facilitate exchange of expertise between pediatric registries, provide counseling to existing and planned pediatric registries, and host pediatric and all-age registries. It is the platform for registry based research.

#### **SwissPedPha**

SwissPedPha performs virtual experiments leveraging advanced pharmacometric modeling and simulation approaches to enhance both design and analysis of clinical trials conducted by SwissPedNet research centers. SwissPedPha also partners with SwissPedDose to analyze national databases and provide a scientific basis for enhanced and personalized treatment strategies in pediatrics.

The collaboration between the hubs and SwissPedPha has still to be increased.

## SwissPedNet's International Network

#### **Enpr-EMA**

Being a member of Enpr-EMA SwissPedNet is recognized on the European stage. In the past two years SwissPedNet has been invited to join several consortia of European projects.

### **PedCRIN** - the Pediatric Clinical Research Infrastructure Network in Europe

PedCRIN develops capacity for the management of multinational pediatric non-commercial clinical trials. The PedCRIN Consortium is led by ECRIN.

Funding period: 2017 to 2020

SwissPedNet is the Swiss Hub of this four-year project funded by the European Union's Horizon 2020 program, launched on the 1st January 2017 (grant agreement number 731046).

#### IMI2 Call and c4c (CONECT4CHILDREN)

SwissPedNet is part of the c4c consortium and 2017 has been used for preparatory work that includes two main topics: How to open studies efficiently and how to run studies efficiently. For the time being working groups elaborate documents, standards and processes for contracts, budgets, feasibility and ethics, site qualification and metrics.

c4c will demonstrate the effectiveness of the network by conducting 4 to 5 academic studies with the following timelines:

- May 2018: a call for non-industry projects will be opened for submission of clinical studies to be conducted via the infrastructure c4c.
- May 2019: selection of the projects.
- May 2020: Proof of viability start of selected projects.

#### **EPTRI - the European Paediatric Translational Research Infrastructure**

The purpose of EPTRI is the creation of a framework for a new pediatric RI within the INFRADEV-2016-2017 single-stage call for proposals. Grant: € 3.00 million by the European Commission

Funding period: 2018 – 2019. The project is coordinated by CVBF Consorzio per valutazioni biologiche e farmacologiche, Italy.

Within this project, payment is only received when Switzerland participates in a clinical trial / project. Max. amount: € 40'000.-/year. (see also https://www.teddynetwork.net/2017/09/01/id-eptriapproval-a-great-success-for-paediatric-medicines-development/)

### **Swiss Clinical Trial Organisation SCTO**

The pediatric clinical research hubs will not establish parallel infrastructures to the CTUs, therefore, the collaboration between the hubs and the CTUs should be fostered. The staff caring for pediatrics and hired with the federal funds could be embedded within a CTU but be dedicated as study employee of the children's hospitals. Models and best practices are in development and will be tested at individual hubs.

SwissPedNet and the SCTO are closely collaborating. As SwissPedNet has no legal entity according to European meanings, the SCTO acts as legal entity and is beneficiary for SwissPedNet within the European projects.

# **General Assembly 2017**

The afternoon session allowed the people to mutually introduce themselves, and their societies were invited to approach SwissPedNet, if they see synergies and to pursue collaborative projects.

SwissPedNet needs to improve its marketing activities as it became clear during the discussions, for many pediatricians still do not know the research infrastructure for pediatrics.

# **Next steps**

SwissPedNet will introduce a practical workshop for young researchers to increase their skills. It is planned to hold the workshop timely close to the General Assembly; therefore, first workshop will be held in November 2018.

Finally, SwissPedNet will set a strategy to promote itself and its activities throughout Switzerland.
